## POSITION PURPOSE

The IBP Supply Manager facilitates:

- The Nuclear Precinct rolling 24-month Supply Planning process (including the oversight of Silicon Capacity plan) and creates and maintains a valid Master Supply Plan for materials and capacities by effectively balancing supply and demand; and acts as the conduit between Supply and Demand for requests and changes to demand and outputs from Supply.
- 2) The integration of the enabling services supporting the Manufacturing operations, with particular focus on AME (Maintenance and Engineering), High reliability, Nuclear Security, Nuclear Safety, Regulatory and other enabling groups.
- 3) The resolution of misalignments identified during the IBP process concerning end to end Supply Chain constrains ANSTO Wide, including our Research and Scientific activities.

## ORGANISATIONAL ENVIRONMENT

## **Key Accountabilities**

- Leads the Supply Planning process through the integrated business planning (IBP) process. Custodian of the valid Nuclear Precinct Supply Plan (including Silicon).
- Facilitate the Supply plan development, including input and analysis.
- Facilitate the ANSTO Supply Review, incorporating NST and Enabling functions. Issue the Supply Review pack.
- Create and maintain a valid and achievable Master Supply Plan balanced to capabilities in the supply chain.
- Ensure a common master plan drives company priorities.
- Integrate master Supply plan with other functions including Maintenance, Engineering, High reliability and other functions.
- Maintains Master data for planning System (IBP SAP) and all relevant documentation up to date.
- Performs UATs and provides advice on system improvements.

- Analysis of the demand and supply balance at the product family and master schedule levels, determining out-of-balance conditions, identifying alternatives, and recommending action for approval.
- Manage requests for change whether changes are due to Demand or Supply constraints.
- Ongoing liaison with Demand Management and Product Coordinator to support integrated planning.
- Manage stability and responsiveness. Work with sales, marketing and manufacturing to better understand competitive lead times for master scheduled items. Seek ways to reduce internal and external lead times as well as lead times to the customer.
- Facilitate strategic decisions on issue resolution & gap closing plans including exploitation of opportunities and mitigation of vulnerabilities.
- Identification, negotiation and resolution of conflicts with respect to material and capacity availability and order-promising integrity.
- Act as internal educator and consultant on master scheduling issues, providing education and training to improve company-wide understanding of MPS functions.
- Lead Root Cause analysis on non-conformance with recommendations for improvements to the Supply & Demand teams.
- Maintenance of planning parameters including planned lead times, delivery times, and order file data for all MPS items.
- Analysing forecast performance and making recommendations to supply chain on inventory plan.
- Ensure a range of KPIs and measures as identified in the Integrated Business Planning process are achieved and improved.
- Ensures Portfolio opportunities with Manufacturing supply chain synergies follow the required stage gates and facilitates the integration of the relevant stakeholders from the supply chain perspective.
- Provide expert, authoritative and evidence based advice to NST and education as required.
- Undertake additional duties as required and during periods of leave of other staff.

## **Decision Making**

- The position works within a framework of legislation, policies, professional standards and resource parameters. Within this framework the position has some independence in determining how to achieve objectives of the unit, including deciding on methods and approaches, operations, project planning and allocation of resources.
- The ANSTO values, organisational corporate plan, business plan, operational excellence program, the group strategy and objectives provide the context for the position.
- The position is fully accountable for the accuracy, integrity and quality of the content of advice provided to the Senior leadership team and is required to ensure that decisions are based on sound evidence, but at times may be required to make effective judgements under pressure or in the absence of complete information or expert advice.
- Determines key work priorities within the context of agreed work plans and will consult with the Senior Leadership Team on complex, sensitive and major issues that have a significant impact on the Organisation


